**PROSHARES INVESTMENT GRADE—INTEREST RATE HEDGED**

### Market overview

The broad U.S. bond market was flat for the quarter, returning 0.0% as measured by the Bloomberg U.S. Aggregate Bond Index. The yield curve twisted a bit during the period, with the middle of the curve rising while longer-term rates fell. Five-year and 10-year Treasury yields rose 30 bps and 2 bps, respectively, while the 30-year Treasury yield fell 14 bps. The U.S. corporate bond market slightly outperformed the broader bond market, eking out a 0.2% gain as measured by the Bloomberg U.S. Corporate Bond Index. Investment-grade credit spreads widened 8 bps during the period, negatively impacting performance. While corporate bond prices fell in aggregate, the income generated by the bonds was generally enough to overcompensate for the drop in prices. Bond investors homed in on the removal of "transitory" from the Fed's vocabulary during the quarter when referring to inflation and began to evaluate a potentially expedited pace of tightening.

### Performance

IGHG declined nearly 0.8% during the quarter, based on NAV, underperforming the investment-grade bond market. The slight widening of investment-grade credit spreads negatively impacted IGHG's performance.

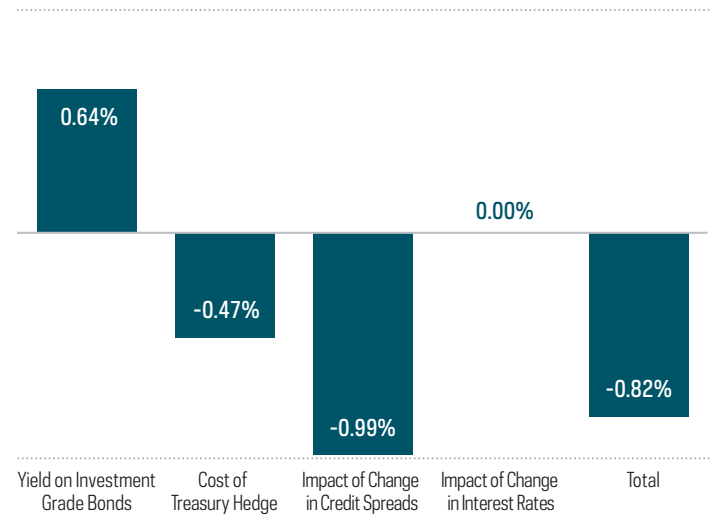

## Performance contribution

The strategy consists of a portfolio of diversified investment-grade bonds, combined with short positions in Treasury futures that are designed to offset the interest rate risk inherent in investment-grade bonds. The strategy's performance can be broken into these components: 1) investment-grade bond yields, 2) the cost of the Treasury hedge, 3) the impact of credit spread changes, and 4) the impact of interest rate changes.

During the quarter, IGHG's bond portfolio yielded approximately 0.6%, while the cost of the Treasury hedge came to roughly 0.5%. The strategy had losses of approximately 1.0% from credit-spread movements. Because of the interest rate hedge constructed within the portfolio, the strategy experienced approximately zero impact from interest rate movements during the period.
