Correlation³ = 1.00

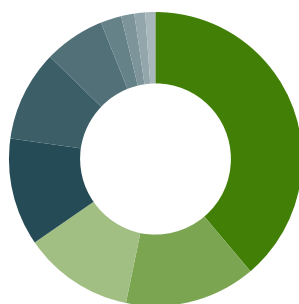
