
Fund performance and index history²

ProShares Short Dow30 seeks a return that is -1x the return of its index (target) for a single day, as measured from one NAV calculation to the next. Due to the compounding of daily returns, holding periods of greater than one day can result in returns that are significantly different than the target return and ProShares' returns over periods other than one day will likely differ in amount and possibly direction from the target return for the same period. 
Daily performance of DOG vs. index during 40 2021


