ProShares Decline of the Retail Store ETF (EMTY) seeks capital appreciation from the decline of bricks-and-mortar retailers through short exposure (-1x) to the Solactive-ProShares Bricks and Mortar Retail Store Index.

ProShares Decline of the Retail Store ETF seeks a return that is -1x the return of a benchmark (target) **for a single day**, as measured from one NAV calculation to the next. Due to the compounding of daily returns, holding periods of greater than one day can result in returns that are significantly different than the target return and ProShares' returns over periods other than one day will likely differ in amount and possibly direction from the target return for the same period. These effects may be more pronounced in funds with larger or inverse multiples and in funds with volatile benchmarks. Investors should monitor their holdings as frequently as daily. About the fund

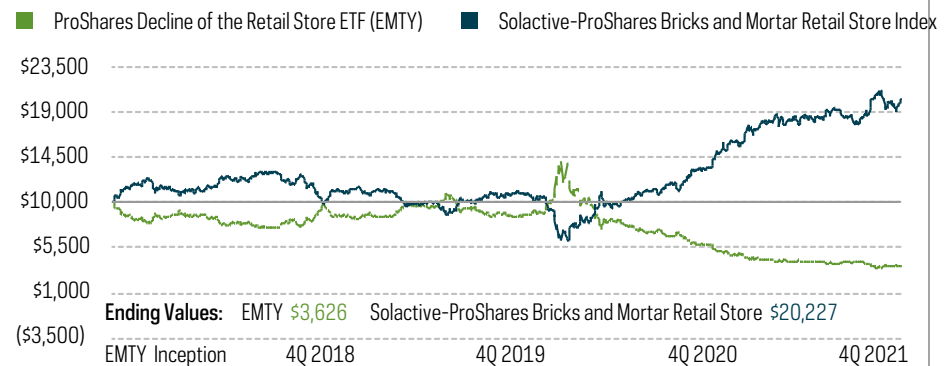
- The first ETF specifically designed to potentially benefit from the decline of bricks-and-mortar retailers.


Growth of \$10,000 since inception²
