

They are not direct costs paid by shareholders or used to calculate net asset value ("INAV"). "Gross expense ratio" is the sum of all applicable fees and expenses. 



⁴Definitions of terms: "Volatility" refers to annualized standard deviation, a statistical measure that captures the variations from the mean of an index's returns and that is often used to quantify the risk of the index over a specific time period. The higher the volatility, the more an index's returns fluctuate over time.
